
A PROCLAMATION TO RATIFY THE FINANCING AGREEMENT BETWEEN THE FEDERAL DEMOCRATIC REPUBLIC OF ETHIOPIA AND THE GOVERNMENT OF THE REPUBLIC OF POLAND

This Proclamation may be cited as the "Government of the Republic of Poland Credit Agreement for financing of Projects in the Modernization of the Economy and the Public Sector as well as Development of Rural Areas Ratification Proclamation No. 905/2015".

2. Ratification of the Agreement

The Loan Agreement signed in Addis Ababa on the 20th day of March, 2015 between the Government of the Federal Democratic Republic of Ethiopia and the Government of the Republic of Poland is hereby ratified.

3. <u>Power of the Ministry of Finance and Economic</u> <u>Development</u>

The Ministry of Finance and Economic Development is hereby empowered to undertake all acts necessary for the utilization of the Loan amount of up to 50,000,000 USD (Fifty million United States Dollars) in accordance with the terms and conditions set forth in the Credit Agreement.

4. Effective Date

This Proclamation shall enter into force on the date of publication in the Federal Negarit Gazette.
