COUNCIL OF MINISTERS REGULATION No. 295/2013

COUNCIL OF MINISTERS REGULATION TO ESTABLISH THE ETHIOPIAN MEAT AND DAIRY INDUSTRY DEVELOPMENT INSTITUTE

This Regulation is issued by the Council of Ministers
pursuant to Article 5 and Article 35 of the Definition of
Powers and Duties of the Executive Organs of the Federal
Democratic Republic of Ethiopia Proclamation No.
691/2010 (as amended).

1. Short Title

This Regulation may be cited as the “Ethiopian Meat and
Dairy Industry Development Institute Establishment
Council of Ministers Regulation No. 295/2013”.

2. Definitions

In this Regulation unless the context otherwise requires:

- 1/ “industry” and “manufacturing activity” shall have
the meaning given to them under sub-article (11) and
(12) of Article 2 of the Commercial Registration and
Business Licensing Proclamation No. 686/2010;
- 2/ “production process” means sequence of operation in
the performance of manufacturing activity;
- 3/ “meat and dairy products” means products including
livestock products and by-products;

፭. ዓላማ

የኢንስቲትዩቱ ዓላማ ለሰጋና ወተት ኢንዱስትሪ ሁለገብ ድጋፍ በመስጠት የቴክኖሎጂ ሽግግር ማፋጠን፣ የልማት እመርታ ማምጣት እና ኢንዱስትሪው በዓለም አቀፍ ደረጃ ተወዳዳሪ እንዲሆን ማብቃት ይሆናል፡፡

4/ “livestock products” means meat, milk, butter and cheese, and includes other products designated by the Institute as livestock products;

5/ “livestock by-products” means by-products such as horn, hoof, blood, bone, intestine and other similar useful by-products of slaughtered animals and includes other by-products designated by the Institute as livestock by-products;

6/ “livestock” means cattle, sheep, goat, chicken and camel and includes other animals designated by the Institute as livestock;

7/ “technology” means methods resulting from research, innovations and new techniques that improve the productivity and quality of meat and dairy products;

8/ “processing” means a mechanism by which the value of a product is increased in terms of type, content or the like;

9/ “Ministry” means the Ministry of Industry;

10/ “person” means natural or juridical person;

11/ any expression in the masculine gender includes the feminine.

3. Establishment

1/ The Ethiopian Meat and Dairy Industry Development Institute (hereinafter the “Institute”) is hereby established as an autonomous federal government office having its own legal personality.

2/ The Institute shall be accountable to the Ministry.

4. Head Office

The Institute shall have its head office in Beshoftu and may have branch offices elsewhere, as may be necessary.

5. Objective

The objective of the Institute shall be to provide all round support to the meat and dairy industry and thereby accelerate technology transfer, achieve transformation and enable the industry to be competitive at international level.

6. Powers and Duties of the Institute

The Institute shall have the powers and duties to:

- 1/ formulate policies, strategies, directives and action plans that assist in the facilitation of the development of meat and dairy industry, and implement same upon approval;
- 2/ conduct research and development and identify relevant technologies applicable to the development of the meat and dairy industry, transfer these technologies to the industry and support them to enter the market thereafter; and encourage the industry to establish research and development units;
- 3/ conduct studies and research, including market research, that support the development of the meat and dairy industry; assist the industry to promote their products in the domestic as well as international markets; and work closely with relevant stakeholders in order to implement effective marketing systems in the industry;
- 4/ collect, analyze and organize technological, market and other data necessary for the development of the meat and dairy industry and disseminate same to users, as may be necessary;
- 5/ provide consultancy services to meat and dairy industry concerning production process, production planning and quality assurance; establish pilot plants and laboratories to support the industry, provide international-level testing services; encourage the industry to establish laboratories and assist them to get certification so as to make them internationally competitive;
- 6/ set up a database related to livestock resources and the industry by conducting a survey on investment opportunities, collect, analyze, organize and timely update information necessary for the development of the sector and disseminate same to users, as may be necessary;
- 7/ follow-up the expansion of infrastructures necessary for livestock market and the availability of facilities such as designated transportation vehicles for livestock and livestock products;

8/ prepare and disseminate project profiles that may be helpful in expanding investment in the meat and dairy industry; conduct pilot studies for those investors desiring to engage in the sector; follow up project implementation and provide remedies concerning problems encountered during implementation; promote investment and assist to remove investment bottlenecks in the sector;

9/ advise investors desiring to engage in the meat and dairy industry sector in the selection of technology, negotiation, construction, erection, and commissioning;

10/ provide practical training on technology, technical matters, marketing and management and other tailor-made training that assist the development and competitiveness of the meat and dairy industry sector, and collaborate with the relevant stakeholders to produce qualified manpower in the sector;

11/ build the capacity of the Institute to international standard through twinning programs so as to support the industry effectively; cooperate with national as well as international public and private institutions which have similar objectives and also encourage similar co-operation among private sector institutions;

12/ cooperate with universities on product and human resource development, conduct joint research activities, provide support in building local research capability and in establishing linkages between the industry and the universities; work with technical and vocational training centers to build the human resource of the sector at lower and middle levels;

13/ undertake international benchmarking studies, compile best practices and assist the industry to implement same so as to build their competitiveness globally;

14/ support the development of input industry so as to ensure the regular availability of inputs to the industry in terms of variety, quantity and quality; extend the necessary support and follow up, based on the respective value chain of the industry, starting from raw material up to global market, to ensure effective linkage among the actors, in particular, support the linkage of micro and small enterprises with medium and large industries in terms of production, technology and training;

15/ promote the development of meat and dairy industry zones to mobilize international and national investors to the sector, and support investors operating in the industry zones;

16/ establish entrepreneurship development program and incubation centers to create new and vibrant entrepreneurs in the sector;

17/ provide support in the acquisition of intellectual property rights and patents for research and technology outputs developed by the sector actors;

18/ promote post harvest technologies, cold chain, modern warehouses, modern transport and other logistics for the sector to reduce post harvest losses;

19/ build the capacity of meat and dairy industry associations so that they play their proper role in the promotion of trade and investment in the sector;

20/ provide support to meat and dairy industry to use renewable energy sources and to operate in environment friendly manner;

21/ charge fees for the services it renders in accordance with the rate approved by the government;

22/ own property, enter into contracts, sue and be sued in its own name;

23/ perform other related activities necessary for the attainment of its objective.

8. Organization of the Institute

The Institute shall have:

1/ an Advisory Council (hereinafter the “Council”);

2/ a Director General and, as may be necessary, Deputy Director Generals, to be appointed by the government; and

3/ the necessary staff.

8. Members of the Council

1/ The Chairperson and members of the Council shall be drawn from the appropriate government offices and the private sector and be appointed by the government.

2/ The number of members of the Council shall be determined as required.

9. Duties of the Council

The Council shall:

- 1/ provide advise on the activities of the Institute;
- 2/ evaluate, and forward its recommendation on policies, strategies, plans, studies and research formulated with the view to facilitate the development of the meat and dairy industry;
- 3/ forward its opinions on capacity building programs;
- 4/ evaluate the implementation of the plans of the Institute every three months and propose remedial directions.

10. Meetings of the Council

- 1/ The Council shall hold a regular meeting once every quarter of the budget year; provided, however, that it may hold an extraordinary meeting whenever found necessary.
- 2/ There shall be a quorum where more than half of the members of the Council are present at a meeting.
- 3/ Decisions of the Council shall be passed by a majority vote; in case of a tie, the Chairperson shall have a casting vote.

11. Powers and Duties of the Director General

- 1/ The Director General shall be the chief executive officer of the Institute and shall direct and administer the activities of the Institute.
- 2/ Without limiting the generality of sub-article (1) of this Article, the Director General shall:
 - a) exercise the powers and duties of the Institute specified under Article 6 of this Regulation;
 - b) employ and administer employees engaged in support services of the Institute in accordance with the federal civil service laws and, in the case of professionals engaged in the core functions of the Institute, in accordance with directives approved by the government following the basic principles of the federal civil service laws;

12. Budget of the Institute

The budget of the Institute shall be allocated by the government.

13. Books of Account

1/ The Institute shall keep complete and accurate books of accounts.

2/ The books of accounts and financial documents of the Institute shall be audited annually by the Auditor General or an auditor assigned by him.

14. Repealed Regulation

The Ethiopian Meat and Dairy Technology Institute Establishment Council of Ministers Regulation No.143/2008 (as amended) is hereby repealed.

15. Transfer of Rights and Obligations

The rights and obligations of the Ethiopian Meat and Dairy Technology Institute established under Council of Ministers Regulation No. 143/2008 (as amended) are hereby transferred to the Institute.

16. Effective Date

This Regulation shall come into force as of the 9th day of August, 2013.
