COUNCIL OF MINISTERS REGULATION TO PROVID FOR THE ESTABLISHMENT OF MELES ZENAWI LEADERSHIP ACADEMY

WHEREAS, it is found necessary to establish leadership institution for the realization of the sustainability of the journey of Ethiopian Renaissance by addressing the question of the leadership of the Renaissance and in achieving the vision of the Great Leader in a reliable manner by generating matured, cultivated, scientific and transcendental thoughts through education, training, research, reflection, analysis and inculcation;

NOW, THEREFORE; this Regulation is issued by Council of Ministers pursuant to Article (5) and (35) of the definition of the powers and duties of the executive organs of the Federal Democratic Republic of Ethiopia Proclamation No. 691/2010 (as amended by Proclamation No.803/2013).

GENERAL CENTRAL

1. Short Title

This Regulation may be cited as the "Meles Zenawi Leadership Academy Establishment Council of Ministers Regulation No. 321 /2014".

2. Definitions

Unless the context otherwise requires; in this regulation:

- 1/ "senate" means the senate of the academy established under Article 17 of this regulation;
- 2/ "trainee" means any natural person who is on training meeting the requirements set by the academy;
- 3/ "units of the Academy" means department, faculty, part, center or school, established as a constituent units of the academy;
- 4/ "service fee" means fee to be paid for knowledge based training, research and other services provided by the academy;
- 5/ "person" means any natural or juridical person;
- 6/ any expression in the masculine gender includes the feminine.

PART TWO

MELES ZENAWI LEADERSHIP **ACADEMY**

3. Establishment

- 1/ Meles Zenawi Leadership Academy (herein after called as the "Academy") is here by established as an autonomous federal government organ having its own legal personality.
- 2/ The academy shall be accountable to the Prime Minister.

4. Head Office

The Academy shall have its head office in Addis Ababa, and may have branch offices elsewhere as may be necessary.

5. Principles of the Academy

In pursuance of its objectives the Academy shall be guided by the following basic principles:

1/ uphold democratic and developmental thought and attitude;

6. Objectives of the Academy

The Academy shall have the following major objectives:

- 1/ on the bases of scientific and in-depth research, establish reliable interdisciplinary education and training system that can produce leader at all levels who is shaped in democratic developmental thought, high level of leadership wisdom, well recognized ability of creativity, critical thinking skill and proactively responding to the public questions;
- 2/ produce the renaissance leadership at all levels that leads the multifaceted efforts to be exerted to get the democratic unity prevailed and laid on firm foundation by building one political and economic community and implement the developmental and democratic thought and philosophy in a scientific manner;
- 3/ disseminate developmental and democratic thought and philosophy in a scientific manner by providing international, continental and regional trainings and preparing forums;
- 4/ conduct leadership capacity building on the basis of missions generated from the general objectives and principles of developmental state in order to lead the mobilization of the public at large and thereby to achieve the goal of the commenced renaissance journey of the country;
- 5/ by following up, and analyzing the strategic affairs having tangible implications on the peace, development and democracy of our

7. <u>Duties and Responsibilities of the Academy</u>

The academy shall have the following duties and responsibilities:

- 1/ prepare leadership at all levels vigilance on the renaissance journey with enriched knowledge and awareness, matured outlook and skill and having commitment and work motive;
- 2/ recruit and prepare competent and ethical instructors having democratic and developmental thoughts, equipped with indepth knowledge of national, regional, continental and international affairs so as to achieve the objective of the academy;
- 3/ provide training on the context of developmental and democratic thought and philosophy to diverse domestic and international leaders and professionals;
- 4/ synchronize and use best experiences in conducting training that promote the awareness, knowledge and skill and support the trainees to enhance problem solving skill;

5/ conduct study on the implementation and outcomes of government policies; supervise pre-training, training sessions and post training activities, evaluate efficiency and quality of training and conduct study and research on problems encountered and submit

- 8/ make efficient and effective activities of education, training, research, communication and inculcation by widely using information technology;
- 9/ create relationship with inland and foreign counterpart academies, research institutions and those having similar objectives;
- 10/award certificates, diplomas, bachelor degree, master's degree, doctorate (PhD) degree or its equivalent for the trainees, subject to senate decisions and curricula to be developed, who have successfully completed their education or training;
- 11/prepare journals and news papers on education and training; conduct appropriate study, research, reflection and analysis on the developmental and democratic thought and philosophy; publish and disseminate
- 12/enhance the institutional capacities of other similar academies to enable them properly accomplish their missions; and support them to implement the training programs in a complementary manners;
- 13/collect service fees for the service it renders in accordance with the rate approved by the board;
- 14/own property, enter into contracts, sue and be sued in its own name;
- 15/undertake other activities necessary for the attainment of its objectives.

8. Organization of the Academy

The Academy shall have:

- 1/ Meles Zenawi Leadership Academy Board (hereinafter called the "Board");
- 2/ Education and Training Council accountable to the board (herein after called the "Council");
- 3/ a President and Deputy Presidents to be appointed by the government;
- 4/ Senate of the academy; and
- 5/ the necessary staff.

9. Members of the Board

The Board shall have the following members:

- 1/ the Prime Minister chairperson;
- 2/ members to be designated by the government;
- 3/ President of the academy;
- 4/ a secretary to be assigned by the board or the academy, as may be necessary.

10. <u>Duties and Responsibilities of the</u> Board

The Board shall have the following duties and responsibilities;

- 1/ being the supreme decision making body of the academy direct and oversee the academy;
- 2/ determine the general policy direction of education, training, research and inculcation of the academy;
- 3/ issue directives to determine the structure of the academy;
- 4/ ensure the academies determinedness as an institution where democratic and developmental thought prevail and be a hub for proliferation core leadership;
- 5/ approve strategic plan of the academy and follow up its implementation

 - f) develop institutional standard of the academy; and ensures that the academy's administrative activities are operated on the basis of the standards;
 - g) employ and administer the employees of the academy in accordance with the directives approved by the board following the basic principles of the civil service laws;

- 3/ the Deputy President delegated by the President shall represent the President in his absence.

17. Members of the Senate

The Senate shall:

- 1/ be presided by the President and have members assigned by the President;
- 2/ be accountable to the President.

18. Duties and responsibilities of the Senate

Without prejudice to the duties and responsibilities assigned to it by the board the Senate shall have the following duties and responsibilities with respect to education and training matters:

Budget of the Academy shall be drawn from:

- 1/ budget allocated by the government;
- 2/ proceeds from services it provides;
- 3/ inheritance, donation and assistance; and
- 4/ other sources of income. .

22. Books of Accounts

- 1/ The Academy shall keep and maintain accurate and complete books of account and financial records.
- 2/ The books of accounts and financial documents of the academy shall be audited annually by the Auditor General or an auditor assigned by Auditor General.

PART THREE MISCELLANEOUS PROVISIONS

23. Power to Issue Directives

- 1/ The Board may issue directives for the proper implementation of this regulation.
- 2/ The Academy may issue directives and manuals for the proper implementation of this regulation and the directives issued under sub-article (1) of this Article.
