Proclamation No. 1022/2017

A PROCLAMATION TO PROVIDE FOR THE DISSOLUTION OF THE AGENCY FOR GOVERNMENT HOUSES

WHEREAS, it is found necessary to dissolve the Agency for Government Houses and to establish it as public enterprise in the form of Corporation;

NOW, THEREFORE, in accordance with Article 55(1) of the Constitution of the Federal Democratic Republic of Ethiopia, it is hereby proclaimed as follows:

1. Short Title


This Proclamation may be cited as the "Agency for Government Houses Dissolution Proclamation No. 1022/2017".

2. Dissolution

The Agency for Government Houses established under Proclamation No. 555/2007 is hereby dissolved.

3. Transfer of Rights and Obligations

The rights and obligations of the Agency for Government Houses are hereby transferred Establishment Regulation No. 398/2017.
