PROCLAMATION No.1040/2017

A PROCLAMATION TO RATIFY THE LOAN AGREEMENT BETWEEN THE GOVERNMENT OF THE FEDERAL DEMOCRATIC REPUBLIC OF ETHIOPIA AND THE OPEC FUND FOR INTERNATIONAL DEVELOPMENT

WHERE AS, a Loan Agreement between the Government of the Federal Democratic Republic of Ethiopia and the OPEC Fund for the International Development is stipulating that the OPEC Fund for International Development provide to the Government of the Federal Democratic Republic of Ethiopia a Loan amount of 30,000,000 USD (Thirty million United States Dollars) for Financing Shambu-Agamsa upgrading Road Project was signed in the United States of America (Washington D.C) on the 20th day of April 2017,

WHERE AS, the House of Peoples' Representatives of the Federal Democratic Republic of Ethiopia has ratified the said Loan Agreement at its session held on the 5th day of July 2017;

NOW, THEREFORE, in accordance with Article 55

1. Short Title

This proclamation may be cited as the "OPEC Fund for International Development Loan Agreement for Financing the Shambu-Agamsa upgrading road project Ratification Proclamation No.1040/2017".

2. Ratification of the Agreement

The loan Agreement that was signed in the United States of America (Washington D.C) between the government of the Federal Democratic Republic of Ethiopia and the OPEC Fund for International Development on the 20th day of April is hereby ratified.

3. Power of the Ministry of Finance and Economic Cooperation

The Ministry of Finance and Economic Cooperation is hereby empowered to undertake all acts necessary for the utilization of the Loan amount of 30,000,000 USD (Thirty million United States Dollars) in accordance with the terms and conditions set forth in the Additional Loan Agreement.

4. Effective Date

This proclamation shall enter into force on the date of its publication in the Federal Negarit Gazette.

Done at Addis Ababa, this 31st day of August, 2017
