# A PROCLAMATION TO RE-ESTABLISH ETHIOPIAN NEWS SERVICE

WHERE AS, the role of News Service in strengthening and sustaining the country's development, peace and democracy as well as democratic unity based on equality and co-existence of its people is vital;

WHERE AS, it becomes necessary to make Ethiopian News Service as national news service, attain institutional and procedural freedom as well as better legal protection to enable it effectively fulfill its role of building the country's image;

WHERE AS, it found necessary to make Ethiopian News Service to be led by taking in to account its work nature and to make its work improvements and efficiency proceeded in better way.

WHERE AS, it found necessary to make working procedure and organization of Ethiopian News Service compatible and competent with international technology and professional development.

**WHERE AS,** it is found necessary to re- establish the Ethiopian News Service to enable it to provide its service in more efficient, quality and competent way.

**WHERE AS**, it is found necessary to create conducive work environment for the work and employees.

WHERE AS, it is found necessary to enable it perform its mission of documenting and keeping major national events and phenomenon effectively by supporting them in writing, sound, photography and film for the use of different Medias and inputs for Study and Research.

WHERE AS, it becomes necessary to create enabling condition to Ethiopian News Service to support itself by engaging in income generating activities.

**NOW, THEREFORE**, in accordance with Article 55(1) of FDRE Constitution, it is hereby Proclaimed as follows:

#### **GENERAL PROVISIONS**

#### 1. Short Title

This Proclamation may be cited as the "Ethiopian News Service Re-establishment Proclamation No. 1115/2019."

#### 2. Definition

In this Proclamation, unless the context otherwise requires:

1/ "News" means idea, event, phenomenon or information that has positive or negative impact on numerous persons or nations, nationalities and peoples, that indicates new events, pass experiences, connects people among themselves and their environment by satisfying the needs of audiences and it also includes opinion poll, output of monitoring and current affairs analysis;

- "ስንዳ ወይም ዶክመንቴሽን" ማለት ትልልቅ አገራዊ ጉዳዮችና ክስተቶችን በፎቶ፣በድምጽ፣በፎቶና በተንቀሳቃሽ ምስል መቅረጽና ለወደፊት ጥቅም በሚችሉበት መልኩ አሰናድቶ ላይ ሊውሳ ማስቀመጥ ነው።፡

- "News related information" means information officially given by the owner and legally endorsed, that further elucidate the issue, phenomenon, idea or the essence of released news in different ways and beyond their presentations as mere news.
- 3/ "Program" includes spot, reportages, programs and documentary films mixed by mode of sound, picture, or sound and picture; presented to inform, give lesson or entertain or inclusively.
- 4/ "Publishing Works" include reports, monitoring outputs, annual books disseminated with the intention to be accessed by the general public or certain organ.
- 5/ "Opinion poll" means studies that include about certain national or current issue or studies on public view, perception and satisfaction about service delivery of certain institution.
- "Advertisement production" means Public and commercial advertisement works that is mixed and prepared in terms of writing, photograph, sound and film.
- 7/ "Documentation" means recording major national issues and phenomena by mode of photograph, sound, photo and film and preparing them for future use.
- 8/ "Region" means any state referred under Article 47(1) of the Constitution of the Federal Democratic Republic of Ethiopia and includes the Addis Ababa and Dire Dawa city Administrations.
- 9/ Any expression in the Masculine Gender includes the Feminine.

#### 3. Establishment

- 1/ The Ethiopian News Service (hereinafter referred to as "The Service" is hereby established by this Proclamation with its own legal personality as an autonomous Federal Government Organ;
- 2/ The Service shall be accountable to the House of People's Representatives.

#### 4. Head office

The Service shall have its head office in Addis Ababa and may have branches and correspondents within Ethiopia and abroad as may be necessary.

#### 5. Objectives of the Service

The Service shall have the following objectives:

- 1/ Collect, organize, analyze and disseminate balanced and accurate news and news related reports as well as programs about the economic, social and political activities Ethiopia undertakes in enhancing development and in building a democratic order, based on the appropriate policies and laws of the country;
- 2/ Build the image of the country;
- 3/ Cover global issues of national interest;
- 4/ Conduct opinion polls on various issues, Publish and disseminate them as found necessary;
- 5/ Serve as a main source of news locally and abroad on issues pertaining to Ethiopia;

6/ Document major national events and phenomena in writing, Sound, photography and film so that they could be used as inputs to various media undertakings and research.

#### 6. Powers and Functions of the Service

The service shall have the following powers and functions:

- 1/ Gather compile and disseminate news and news related information to enhance the free flow of ideas and views;
- 2/ Provide Photography and production services along with news and news related information;
- 3/ Prepares and disseminates spots, reportages, programs and documentary films that ensure the participation and benefits of the people;
- 4/ Document major national events and phenomena in writing, sound, photography and film for the use of the media and as inputs for research;
- 5/ Conduct opinion polls on current and national issues publish and disseminate same;
- 6/ Establishes its own broadcast and print media organizations that enable it to carry out its objective;
- 7/ Installs receivers, transmitters and other facilities essential for its activities at appropriate places, in collaboration with the pertinent bodies and manage them;
- 8/ Establish relation with counterpart organs inside and outside of the country;

- 12/ without prejudice to the Commercial Code, produces Public and Commercial Advertisement;
- 13/ Collects fees for services rendered as per the Regulation issued by the Council of Ministers;
- 14/ Owns property, enters into contract, sues and be sued in its own name.
- 15/ Undertakes other activities that enable it to attain its objectives.

#### 7. Organization of the Service

The Service shall have:

- 1/ Ethiopian News Service Board (hereinafter referred
  to as "The Board");
- 2/ A Chief Executive Officer and as may be necessary Deputy Chief Executive Officers who shall be nominated by the Prime Minister and appointed by the House of Peoples Representative's; and
- 3/ The necessary staff.

#### 8. About the Board

- 1/ Members of the Board, including the Chairperson, shall be nominated by the Prime Minister and appointed by the House of People's representatives. Although their number shall be determined as deemed necessary, it shall not be less than five.
- 2/ The Board shall consist of representatives of appropriate institutions and different parts of the society.
- 3/ The Board shall be accountable to the House of people's Representatives.
- 4/ The term of the Board shall be 5 years.
- 5/ The Chief Executive Officer of the Service shall participate as Secretary without vote.
- 6/The Board may prepare its own operational Guideline.

#### 9. Power and Functions of the Board

The Board shall have the following powers and functions:

- 1/ Ensure that government policies and laws pertaining to the mass media are implemented by the Service;
- 2/ Supervise the implementation of the objectives of the Service as well as the powers and duties specified under Articles 5 and 6 of this Proclamation;
- 3/ Ensure that News and News related information as well as programs produced by the Service bring National Consensus and reflect the accurate image of the Country;

#### 10. Meeting of the Board

- 1/ The Board shall meet at least once every two months.
- 2/ In case of emergency, the Board may meet at any time upon the request of the Chairperson or at least one third of the Board members:
- 3/ There shall be a quorum where more than half of its members are present;
- 4/ Decisions of the Board shall be made by a majority vote. In case of tie, the Chairperson shall have a casting vote.

#### 11. Power and Functions of the Chief Executive Officer

- 1/ The Chief Executive Officer shall manage and administer the Service with the general directions given by the Board, and implement the power and functions of the service provided under Article 6 of this Proclamation.
- 2/ Without Prejudice to the generalities of sub-Article (1)of this Article; the Chief Executive Officer shall:

# 12. <u>Power and Functions of the Deputy Chief</u> Executive Officers

- 1/ Each Deputy Chief Executive Officer shall lead and coordinate the sector to which he is appointed, and also perform other activates assigned to him.
- 2/ Act on behalf of the Chief Executive Officer in his absence.

#### 13. Reporting

The Service shall submit periodic activity reports to the House of People's Representatives.

#### 14. Budget

The Budget of the Service shall be from the following sources:

- 1/ The Budget allocated by the Government;
- 2/ From the service payment that is collected in accordance with this Proclamation that will be determined by the Regulation to be issued by Council of Ministers.

#### 15. Books of Account

- 1/ The Service shall keep complete and accurate books of account and financial records;
- 2/ The books of account and financial records as well as other documents of the Service shall be Audited annually by the Auditor General or other Auditors assigned by the Auditor General.

#### 16. Authority to Issus Regulation and Directive

- 1/ The House of People's Representatives shall issue Regulation for the implementation of this Proclamation.
- 2/ The Board may issue Directives that are necessary for the implementation of this Proclamation and different functions of Service.

#### 17. Transfer of Rights and Duties

The rights and obligations of Ethiopian News Agency, which was established by Regulation No. 319/2014, are transferred to the Service.

This Proclamation shall enter into force on the date of its publication in the Federal Negarit Gazette.
