COUNCIL OF MINISTERS REGULATION No. 254/2011

COUNCIL OF MINISTERS REGULATION TO PROVIDE FOR THE ESTABLISHMENT OF THE ETHIOPIAN NATIONAL THEATER

This Regulation is issued by the Council of Ministers pursuant to Article 5 and Article 34 of the Definition of Powers and Duties of the Executive Organs of the Federal Democratic Republic of Ethiopia Proclamation No. 691/2010.

1. Short Title

This Regulation may be cited as the "Ethiopian National Theater Establishment Conneil of Ministers Regulation No.254/2011". *0349.8CA

2: Definitions

In this Regulation:

- 1/ "Ministry" means the Ministry of Culture and Tourism;
- 2/ any expression in the masculine gender includes the feminine. STANDARD SERVICE

3. Establishment

- 1/ The Ethiopian National Theater (hereinafter the "National Theater") is hereby established as an autonomous federal government organ having its own legal personality. PARTY
- 2/ The National Theater shall be accountable to the Ministry.

4. Head Office

The National Theater shall have its head office, in Addis Ababa.

5. Objectives

The National Theater shall have the following objectives:

- 1/ to develop, maintain and promote the traditional performing arts of the nation, nationalities and peoples of Ethiopia;
- 2/ to develop and present various artistic works having beauty of creative performing art to entertain the public while transmitting important messages and creating attitudinal changes with a view to encouraging them to participate in and benefit from the development of the country, the democratization process and realization of good governance.

6. Powers and Duties of the National Theater

The National Theater shall have the powers and duties to:

- 1/ ensure the fair presentation and popularization of the traditional performing arts of the nations, nationalities and peoples of Ethiopia, at national and international level, while preserving their cultural values and artistic beauty;
- 2/ study the authentic traditional performing arts of the nations, nationalities and peoples from their sources and organize and preserve them, while maintaining their artistic beauty, in the form of script, picture and sample materials with a view to transmitting them to the next generation and to make them available for use;
- 3/ provide technical and information support to professionals of the sector and encourage them to present their artistic works at regional, national and international stages in order to promote the development of artistic activities in the country;
- 4/ organize and conduct seminars, workshops, conferences and consultation panels to promote the development of artistic activities in the country;
- 5/ provide capacity building training in the fields of theater, music, dance, stage management and leadership skills to professionals leaders of the sector:
- 6/ produce dramas and music having artistic quality to mobilize the public for peace, democracy and development and present them on stages and through convenient mass media;
- 7/ organize stages for artistic events;

- 8/ encourage and support professionals engaged in the fields of creative art and research work;
- 9/ introduce Ethiopian performing arts to the peoples of Africa and undertake experience sharing activities to foster unity and cultural ties in the continent;
- 10/ host artistic teams of other countries and work in cooperation with them for the development of artistic works to promote international cooperation and friendship;
- 11/ collect fees from theater and music shows it presents and from other services it provides;
- 12/ own property, enter into contract and sue and be sued in its own name;
 - 13/ carryout such other related activities necessary for the attainment of its objectives.

7. Organization of the National Theater

The National Theater shall have:

- 1/ a Director General to be appointed by the government; and
- 2/ the necessary staff.

8. Powers and Duties of the Director General

- 1/ The Director General shall be the chief executive officer of National Theater and shall, subject to the general direction of the Ministry, direct and administer the activities of the National Theater.
- 2/ Without prejudice to the generality of subarticle (1) of this Article, the Director General shall:
 - a) exercise the powers and duties of the National Theater specified under Article 6 of this Regulation;
 - b) prepare and submit to the Ministry the work programs and annual budgets of the National Theater and implement same upon approval by the government;
 - e) employ and administer the employees of the National Theater in accordance with the Federal Civil Service laws;
 - d) effect payment in accordance with the approved work program and budget of the National Theater;
 - e) represent the National Theater in all its dealings with third parties;
 - f) prepare and submit to the Ministry the performance and financial reports of the National Theater.

The National Theater's budget shall be allocated by the government.

10. Books of Accounts

- 1/ The National Theater shall keep complete and accurate books of accounts.
- 2/ The books of accounts and financial documents of the National Theater shall be audited annually by the Auditor General or by auditors assigned by the Auditor General.

11. Transfer of Rights and Obligations

The rights and obligations of the entity known as the Ethiopian National Theater are hereby transferred to the National Theater.

12. Effective Date

This Regulation shall enter into force on the date of publication in the Federal Negarit Gazeta.
