PROCLAMATION NO.1212/2020

A PROCLAMATION TO RATIFY THE AGREEMENT BETWEEN THE GOVERNMENT OF THE FEDERAL DEMOCRATIC REPUBLIC OF ETHIOPIA AND THE GOVERNMENT OF THE STATE OF OATAR ON THE PROMOTION AND RECIPROCAL PROTECTION OF INVESTMENT

WHEREAS, the Agreement between the Governments of the Federal Democratic Republic of Ethiopia and the State of Qatar on the Promotion and Reciprocal Protection of Investment was signed in Doha Qatar on 14th November, 2017.

WHEREAS, the House of Peoples' Representatives of the Federal Democratic Republic of Ethiopia has ratified the said Agreement at its session held on 25th day of June, 2020;

NOW, THEREFORE, in accordance with Article 55 (1) and (12) of the Constitution of the Federal Democratic Republic of Ethiopia, it is hereby proclaimed as follows.

1. Short Title

This Proclamation may be cited as "the Agreement between the Governments of the Federal Democratic Republic of Ethiopia and the State of Qatar on the Promotion and Reciprocal Protection of Investment Ratification Proclamation No.1212/2012".

2. Ratification of the Agreement

The Agreement between the Governments of the Federal Democratic Republic of Ethiopia and the State of Qatar on the Promotion and Reciprocal Protection of Investment signed in Doha Qatar on 14th November, 2017, is hereby ratified.

3. Implementing Organ

The Ethiopian Investment Commission is hereby empowered to implement the Agreement.

4. Effective Date

This Proclamation shall come into force upon publication in the Federal Negarit Gazette.
