# A PROCLAMATION TO RATIFY THE LOAN AGREEMENT BETWEEN THE FEDERAL DEMOCRATIC REPUBLIC OF ETHIOPIA AND THE OPEC FUND FOR INTERNATIONAL DEVELOPMENT

WHEREAS a Loan Agreement, between the Government of the Federal Democratic Republic of Ethiopia and the OPEC Fund for International Development Stipulating that the OPEC Fund for International Development provide to the Federal Democratic Republic of Ethiopia a Loan amount of twenty million United States Dollars (USD 20,000,000) for financing the Energy Access Project was signed in Vienna, on the 23<sup>rd</sup> day of February 2011;

WHEREAS the House of Peoples' Representatives of the Federal Democratic Republic of Ethiopia has ratified said Loan Agreement at its session held on the 19<sup>th</sup> day of May, 2011;
