COUNCIL OF MINISTERS REGULATION No. 258/2011

COUNCIL OF MINISTERS REGULATION TO PROVIDE FOR THE ESTABLISHMENT OF THE ETHIOPIAN NATIONAL CULTURAL CENTER

This Regulation is issued by the Council of Ministers pursuant to Article 5 and Article 34 of the Definition of Powers and Duties of the Executive Organs of the Federal Democratic Republic of Ethiopia Proclamation No. 691/2010.

1. Short Title

This Regulation may be cited as the "Ethiopian National Cultural Center Establishment Council of Ministers Regulation No. 258/2011".

2. Definitions

In this Regulation unless the context otherwise requires:

Turkey of history

- 1/ "culture" means spiritual and material expressions of a community that has been created through historical processes and that identifies the community from others, and includes the common methods used to enrich and pass same to the next generation;
- 2/ "cultural value" means the attitude, belief or feat that has been given regard by a certain community;
- 3/ "cultural expression" means the material, spiritual or intellectual expressions by which a community is identified from others;

- 5/ any expression in the masculine gender includes the feminine.

3. Establishment

- 1/ The Ethiopian National Cultural Centre (hereinafter the "Center") is hereby established as an autonomous federal government office having its own legal personality.
- 2/ The Center shall be accountable to the Ministry.

4. Head office

The Center shall have its head office in Addis Ababa.

5. Objective

The objective of the Center shall be to contribute to the development of cultural values and expressions and cultural professions of nations, nationalities and peoples of Ethiopia and thereby make them generate social, economical and political benefits.

6. Powers and Duties of Center

The Center shall have the powers and duties to:

- 1/ in collaboration with the appropriate bodies, study, develop and promote the cultural values and expressions of nations, nationalities and peoples of Ethiopia;
- 2/ organize and host cultural weeks of the nations, nationalities and peoples of Ethiopia;
- 3/ in collaboration with the appropriate bodies, provide training support in the field of design development and technology application with a view to improve cultural handicraft products;
- 4/ organize forums for conducting criticisms on literary and artistic works as well as memorial forums for selected literary and artistic works and professionals;
- 5/ provide multipurpose hall services;
- 6/ establish working and experience sharing relationships with similar institutions of regions and of other countries;
- 7/ collect income generated from the services it provides;
- 8/ own property, enter into contracts, sue and be sued in its own name;
- 9/ carry out such other related activities necessary for the attainment of its objectives.

7. Organization of the Center

The Center shall have:

- 1/ a Director General to be appointed by the government; and
- 2/ the necessary staff.

8. Powers and Duties of the Director General

- 1/ The Director General shall be the chief executive officer of the Center and, subject to the general directives of the Ministry, direct and administer the activities of the Center.
- 2/ Without limiting the generality stated under subarticle (1) of this Article, the Director General shall:
 - a) exercise the powers and duties of the Center stated under Article 6 of this Regulation;
 - employ and administer the employees of the Center in accordance with the federal civil service laws;
 - prepare and submit to the Ministry the annual budget and work program of the Center and implement same upon approval;
 - d) effect payments in accordance with the approved budget and work program of the Center;
 - represent the Center in all its dealings with third parties;
 - prepare and submit to the Ministry the performance and financial reports of the Center.
- 3/ The Director General may delegate part of his powers and duties to officers and employees of the Center to the extent necessary for the efficient operation of the Center.

9. Budget

The Budget of the Center shall be allocated by the government.

10. Books of Accounts

- 1/ The Center shall keep complete and accurate books of accounts.
- 2/ The books of accounts and financial documents of the Center shall be audited annually by the Auditor General or by an auditor appointed by him.
