REGULATION NO. 525/2022

COUNCIL OF MINISTERS REGULATION TO PROVIDE FOR THE ESTABLISHMENT OF NATIONAL TEHADSO COMMISSION

This Regulation is issued by Council of Ministers pursuant to Article 103 of the Definition of Powers and Duties of the Executive Organs Proclamation No. 1263/2021.

Part One

General Provisions

1. Short Title

This Regulation may be cited as the "The Establishment of the National Tehadso Commission Council of Ministers Regulation No. 525 /2022".

2. Definition

In this Regulation, unless the context otherwise requires:

- 1/ "Ex-Combatant" means a former armed combatant who took part in conflicts in any part of the country, being a member of an organized armed group, and designated as such for demobilization and reintegration based on criteria to be defined pursuant to a Directive to be issued in accordance with this Regulation;
- 2/ "Firearm" shall have the definition given in the Firearm Administration and Control Proclamation no. 1177/2020 and includes light and heavy armaments used during the conflict period;
- 3/ "Demobilization" means where combatants would no longer belong to the armed group with which they were participating in the conflict with the aim of returning them to civilian life and reintegrating them in the society;
- 4/ "Reintegration" means returning excombatants into their previous civilian life, to assist them to towards sectors where they may find employment and reinserting them into society in a sustainable manner and assisting them to regain their peaceful livelihood;

- 5/ "Agreement" means an agreement undertaken for the cessation of conflict between the Government of the Federal Democratic Republic of Ethiopia and an organized armed group that took part in the conflicts that broke out in any part of the country;
- 6/ Any expression in the masculine gender includes the feminine.

Part Two Establishment, Objective, Organization, Duties, and Responsibilities of the Commission

3. Establishment

- 1/ Ex-Combatants Demobilization and Reintegration National Tehadso Commission (hereinafter the "Commission") is hereby established as an autonomous Federal Government office having its own legal personality.
- 2/ The Commission shall be accountable to the Ministry of Peace.

4. Head Office

The Head Office of the Commission shall be in Addis Ababa and may establish branch offices elsewhere as may be necessary.

5. Objectives of the Commission

The commission shall have the following objectives:

1/ Demobilize and sustainably reintegrate ex-combatants thereby enabling them to have peaceful livelihoods;

6. Duty and Responsibility of the

Commission

The Commission shall have the following duty and responsibilities:

- 1/ Set up and manage cantonment sites for ex-combatants;
- 2/ In collaboration with concerned bodies, shall make available psychological and other necessary support to excombatants until they reintegrate into the society. The details shall be determined by a Directive to be issued by the Commission;
- 3/ Ensures the dependability of the security of the cantonment sites in collaboration with concerned security bodies;
- 4/ In collaboration with concerned bodies, shall make available training that are essential to the sustainable livelihood of ex-combatants:
- 5/ In collaboration with concerned bodies, provide necessary training and empower ex-combatants to be equipped for work;

- 6/ Make available support that would enable ex-combatants, who are unable to sustainably pursue their livelihood due to injuries they sustained in the conflict, to be self-sufficient in accordance with conditions to be determined by a Directive;
- 7/ Shall cause to be delivered , in collaboration with concerned bodies, medical service to ex-combatants who have sustained permanent health problems due to the effects of the conflict;
- 8/ Advise the Government on policy and strategies concerning matters related to the duty and responsibility of the Commission entrusted to it by this Regulation;
- 9/ Coordinate and lead stakeholders in the process of reinserting and reintegrating ex-combatants;
- 10/ Ensure the special needs of excombatants, especially disabled, women and children, are taken into consideration in reintegration activities;
- 11/The Commission may initiate

 Directives necessary for the effective
 implementation of this Regulation to be
 approved by Council.
- 12/ Perform other related necessary activities to meet its objectives.

7. Organization of the Commission

The Commission shall have:

- 1/ Ex- Combatants Demobilization and Reintegration National Council (hereinafter called "Council");
- 2/ Commissioner and Deputy
 Commissioner/s; to be appointed by the
 Prime Minister:
- 3/ Staff necessary to accomplish its objectives.

8. Term of the Commission

- 1/ The term of the Commission shall be two(2) years.
- 2/ If necessary, the term of the Commission may be extended by the Council of Ministers.

9. Members of the Council

- 1/ The Council shall be chaired by the Minister of Peace and have the State Ministers of each of the following institutions as its member:
 - a) The Ministry of Defense
 - b) The Ministry of Labor and Skill
 - c) The Ministry of Women and Social Affairs
 - d) The Ministry of Health
 - e) The Ministry of Education
 - f) The Ministry of Finance
 - g) Other members to be assigned by the Prime Minister.
- 2/ Commissioner of the Commission shall serve as secretary of the Council.

10. Meeting of the Council

- 1/ The Council shall hold at least four regular meetings annually; However, it may hold an extraordinary meeting at any time when it deems necessary;
- 2/ The quorum of the members of the council is constituted if fifty plus one (50+1) of the members are present;
- 3/ The decisions of the Council shall be held by Consensus; However, if no Consensus is reached the decisions shall be passed by a majority vote of members present;
- 4/ In the event of a tie, the chair of the meeting shall have the casting vote;
- 5/ Without prejudice to the provisions of this Article, the Council may adopt its own rules of procedure of a meeting.

11. Duty and Responsibility of the Council

The Council shall have the following duty and responsibilities:

- 1/ Follow up and ensure the cantonment sites are established with dependable security and protection and the provision of necessary assistance;
- 2/ Give directions concerning the Commission's relationship with various stakeholders;

- 3/ Ensure the proper utilization of funds obtained from the Government allocated budget and funds solicited from various legal sources with the aim of reinserting and reintegrating ex-combatants;
- 4/ Shall establish committees necessary for the functions of the Commission;
- 5/ Examine and adopt the annual budget, plan and report of the Commission and the secretariat:
- 6/ Adopt Directives to be issued by the Commission.

12. <u>Power and Responsibility of the Commissioner</u>

The Commissioner shall have the following responsibilities and powers:

- 1/ The Commissioner of the Commission shall be the Chief Executive Officer of the Office and shall direct and administer the activities of the Commission.
- 2/ Without limiting the generality of Sub-Article (1) of this Article, the Commissioner of the Commission shall:
 - a) exercise the powers and duties of the Commission specified under Article 6 of this Regulation;
 - b) organize the Commission, employ and administer employees of the Commission in accordance with the Federal Civil Service laws;
 - c) prepare the annual budget and work program of the Commission; and implement same upon approval;

- 3/ The Commissioner of the Commission may delegate part of his powers and duties to officials and employees of the Commission to the extent necessary for the efficient performance of the activities of the Commission.

13. Powers and Duties of the Deputy Commissioner

- 1/ Carry out the powers and duties specifically entrusted to them by the Commissioner of the Commission.
- 2/ In the absence of the Commissioner, the Deputy Commissioner delegated shall act on behalf of the Commissioner.

Part Three **Miscellaneous Provisions**

14. Source of Budget

- 1/ The budget of the Commission shall be allocated by Government.
- 2/ Without prejudice to Sub-Article (1) of this Article, the Commission may collect fund from other legal sources.
